REGULATION ON INCREASED CONTROLS AND EMERGENCY MEASURES



Regulation 2019/1793

Amendments from May 2021 (regulation 2021/608):

Annex 1:

- Goji berries from China pesticides delisted
- Dried vine fruit from Turkey OTA delisted

Annex 2:

- Hazelnuts from Turkey AFLA Move to Annex I with the same frequency of 5 %
- Peanuts from Brazil AFLA Move to Annex I with the same frequency of 10%
- Peanuts from China AFLA Move to Annex I under a revised frequency of 10%.
- Peanuts from India AFLA Increase the frequency from 10% to 50%.

Both Annexes: the CN code for roasted Sesamum seeds added

From April 2021: New model official certificate for Annex II.



Pending amendment

- The US pistachios (currently at 10%) will be delisted
- The testing for US peanuts to be increased from current 10% to 20%

Disclaimer: the draft text is not yet available

- The text was presented to the Standing Committee 17-18 June
- Vote by a written procedure (usually for a few days). COM expected to start it around 24 June, after the feedback of the Commission Legal Service on the text
- COM to keep FRUCOM informed regarding the date of entry into force, currently estimated to be around early August

EU COMMISSION OPENS COMMENTS ON TWO DRAFT REGULATIONS ON ORGANIC IMPORTS

- 1. **Draft delegated regulation -** rules on the official controls in respect of consignments of organic products and in-conversion products intended for import into the Union and on the certificate of inspection.
- 2. **Draft implementing regulation -** rules on documents and notifications required for organic and in conversion products intended for import into the Union. Also lists the EU countries' obligations to notify non-compliance found during official controls at the entry into the EU
- Feedback Period: 14 June 2021 12 July 2021

- The Commission Delegated Regulation with rules on the information to be sent by third countries and by control authorities and control bodies for the purpose of supervision of their recognition under Article 33(2) and (3) of Council Regulation (EC) No 834/2007 for imported organic products

- WTO NOTIFICATIONS: MODEL CERTIFICATE FOR OPERATORS IN THIRD COUNTRIES AUTHORISED FOR ORGANIC PRODUCTION AND CONTROL AUTHORITIES
- The EU Commission has notified WTO about the draft Commission Implementing Regulation laying down certain rules concerning the certificate issued to operators, groups of operators and exporters in third countries involved in the imports of organic products into the Union and establishing the list of recognised control authorities and control bodies in accordance with Regulation (EU) 2018/848.

Brexit and trade in organics: meeting 19 May 2021

- The only UK certification body currently accepted by the EU is the Soil Association. Comments by EU Commission:
- In 2020, given the risk the parties could not agree on the EU-UK agreement, and organic products from UK are considered non-EU, the Commission recognised 6 UK control bodies indicated by the UK, regulation 2020/2196.
- However, the EU-UK TCA entered into force in May 2021. Annex 14: the EU has recognised equivalence with the UK. This applies to unprocessed agricultural/aquaculture products produced in the UK, or processed in the UK from the local or imported ingredients. Extract from Annex 14 EU-UK agreement: "The organic products listed in this Appendix shall be unprocessed agricultural or aquaculture products produced in the United Kingdom or processed agricultural products for use as food or feed that have been processed in the United Kingdom with ingredients that have been grown in the United Kingdom or that have been imported into the United Kingdom in accordance with United Kingdom laws and regulations."



Brexit and trade in organics: meeting 19 May 2021

- Certification bodies notified by the UK will be recognised by the EU.
- In reply to FRUCOM's question, the official explained that draft legislation will be prepared in the next weeks, the Commission hopes to vote in July COP (Committee on Organic Products). Update 28 June: according to the Commission, this is being slightly delayed, the UK bodies have received a letter from the Commission.
- Answering the question about the product scope (concretely about the products imported into the UK, unprocessed in the UK), the Commission specified they are not in the scope of the agreement, but the scope is already very large if compared to agreements with other third countries.
- A participant commented that the EU organic producers are still facing the prospect of having to submit hard copy certificates with organic products exported from EU to the UK from 1st October, and the EU organic producers will be impacted by this.



SO2: ECHA's Risk Assessment Committee proposed re-classification



SO2

- FRUCOM has been contacted by a consultant on behalf of the Lead Registrant (LR) for SO2, the Sulphuric Acid REACH Consortium (SAC), supported by the European Sulphuric Acid Association (ESA) and Sulfur Dioxide based Chemicals REACH Consortium (SDIOC).
- Following the submission by Germany of a harmonized classification and labeling (CLH) dossier, an additional classification of germ-cell mutagenicity cat. 2, as well as skin sensitization, is proposed.
- This consortium considers this proposed classification not scientifically warranted.
- In their view, a possible adoption of a decision can be expected already in September 2021 at the Risk Assessment Committee (RAC) of ECHA the European Chemicals Agency.



SO2

- Such potential re-classification of SO2 would have consequences:
- Food preservation is an important function of SO2 and of sulfites as derivatives. They are approved for food use (E221, E223, E224). Key uses include the preservation of dried fruits (e.g., apricots) as well as protection of food against melanosis.
- There is a natural endogenous sulfite background and presence in many food items and those produced by fermentation
- No alternatives in many food uses exist. Alternatives are significantly more costly and not an improvement.
- Even if there is no imminent formal impact, there will be a significant impact driven by a change in the public perception of a possibly labeled 'CMR carcinogenic, mutagenic, toxic for reproduction' substance.
- The consultant enquires about the possibility of sending a support letter to the national authorities.
- Short letter and contacts received in Spain, Italy, Germany, France, the Netherlands; if agree, national associations could send letters to national contacts ASAP







There are two important nutritional attributes common to nuts and dried fruit that have a great deal in common when it comes to the EU nutrition and health claims regulations (NHCRi). Aspirational objectives:

Code of Conduct: Pros and cons

Cons: annual reporting, no clarity regarding responsibility for hosting the website, collection of documents, reports, commitments, the annual evaluation of progress and commitments, methodology, use of information.

The benefits of signing the CoC now (rather than waiting until later) would be:

- 1. First mover advantage
- 2. Setting the benchmark on commitments in your industry / sector
- 3. Being (perceived as) a team player
- 4. Avoid / delay regulation
- 5. Reputational (avoid potential risk of name and shame)
